# **Chapter 1 Product introduction**

### 1.1 Brief introduction



It realizes the intelligent and efficient management of passage.. The turnstile is the best choice for access control of modern building.

Full high series are fully applicable to a high traffic flow places like school, factory, park, housing estate and other places.

## 1.2 Product structure and principle

The structure of the product is mainly composed of mechanical system and electric control system.

The mechanical system is composed of upper box, side column, guardrail, rotation shaft, pedestal bearing, core.

The electric control system consists of access control device, control board, direction indicator,

position sensor, solenoid, damper, power supply.

### System Operation Principle

- 1) Turn on the power, 2 seconds later; the system enters into work mode; the rod can't be turn.
- 2) After swipe legal card or code and fingerprint, Access control device send opening signal to control board.
- 3) The control board receives open signal, control indicator to green, solenoid open, The rod of rotation can be pushed to 90 degree or 120 degree.
- 4) After the passenger push rod and then rotation turn to 90 or 120 degree , the position sensor send close signal to control board, the solenoid lock immediately
- 5) Full turnstiles will lock after 5 seconds if the passenger swipe card but do not pass.

- Please test all function before using;


# 2.2 Equipment Installation


- 2) Ensure the installation location and the system composition ,prepare to install after carrying out the system planning;
- 3) Make well of installation of equipment foundation base.

4) Assemble the machine, refer to the picture.



Assemble both sides of guardrail 1 part and 2 part firstly. Then place the 3 part top upper box over the 1 part and 2 part and tighten the mounting screws; lay 4 part bearing mechanism at the bottom of a rotating shaft; Install 5 part rotation, tighten the top mounting screws; Check the verticality of the shaft. Adjust and check the level and vertical of the machine.


- 5) Mark the fixing position of expansion bolts according to fixing plate on the bottom of each turnstile.

- 7) Tighten the expansion screw after the functional test is completed







# 2.4 Debugging instruction


- 1) Check wire: Check whether the connection wire of the gate and the power line are properly connected before power on.
- 2) Function test:
- Access control relay time should be set to 0 seconds or 1 second;
- Rod can not push without swipe valid card
- Indicator will show green and the rod of rotation can be pushed to 90 degree or 120 degree when swipe valid card.
- If passager not go through ,turnstile will lock after 5 seconds

### 2.5 Notice of use

- If it tests well before installation, then fixed it; before you install and maintain it, please cut off the power;
- The product must be earthed, and an earth leakage breaker is necessary on the power supply;
- Follow the order and pass one by one
- Please keep the control button or remote control far away from the children;
- Please don't use the turnstile under the thunder and lightning condition to get rid of damage to the equipment.





# Chapter 4 Trouble shooting and maintenance

# 4.1 Trouble shooting

### Q1:When access board send open sigal, arm move reverse and indicator show reverse?

Reasons: open signal reverse connection

Solotion: exchange SW1 GND and SW2 GND terminal of board.

### Q2: Indicator is not working?

Reasons: 1. wires loose 2. indicator or board damage

Solution:

- 1. Check connect wire of indicator
- 2. Repalce indicator or board.

### Q3: How to achieve free for one way?

1. Remove one of square solenoid

### Q4: Arm can not push when swipe card and indicator show green?

Solution: 1. Check 24V GND output for square solenoid 2. Replace new board or solenoid

### Q5: Passing two or three people after swipe card at a time.

### Reasons:

- 1. The Positon sensor didn't be touched by the right screw cap when the turn plate rotating. (Or didn't receive the effective signal even touched)
- 2. The square solenoid does not stretch smoothly.
- 3. Control baord damage

### Solution:

- 1. Move the position senor inward ,Check connect wires to board
- 2. Adjust square solenoid or replace new one.

- 3. Changing the square solenoid.
- 4. Replace a new board.

### Q6: Rod can't turn 90 degrees or 120 degree for one pass?

### Reasons:

- 1. The position sensor is too close to the wheel;
- 2. If the speed go through is too slow and times out.

### Solution:

- 1. Open the cover of to box, adjust position senosr
- 2. Set DIP switch

### Q7: It is hard to push the shaft rotation?

Reasons: 1. Bottom bearing rust or damage; 2. The shaft is not vertical

Solution: 1. Replace new bearing 2. Adjust the shaft to vertical

### 4.2 Maintenance

Full high turnstile require regular maintenance by professionals and daily cleaning to ensure long-term stability and extended equipment life.

- 1. Maintenance Content:
- Keep the turnstile housing and card reader panels of turnstile gates clean;
- Fasten and lubricate the internal movement structure;
- Check the dust of the driver board and make it cleans.
- Check the connectors and wiring points to ensure the reliability of the connection.
- Check the bearings at the bottom of the shaft

### 2 Maintenance Methods:

- 1. Cleaning: Check the housing and card reader panels of the gate, and remove the dust and other dirt to make them clean; wipe rust inhibitor to keep stainless steel bright
- 2. Rust removal and Lubrication: Check the movement of the flap /slide gate and swing gate, remove

rust with sand paper and spread with anti-rust oil if corroded;

- 3. Screws fastening: Check the connection of the various moving parts, fasten the screws where they are loose to avoid causing fault for long-running;
- 4. Cleaning the bearings at the bottom of the shaft and add grease.
- 5. Circuit board cleaning: Cut off the power, and wipe dust of the board by using a clean brush;
- 6. Lines Checking: Check the connecting lines and solder reinforcement if they are loose off.
